- III. Fire Department Report. Brad Harding read and reviewed the November 2019 report; with a total of 13 calls; Fire-3; Rescue-0; EMS-8; Lift Assist-2 and Stand by-0. President Crist replied as Brady Twp. has contracted with Muncy Borough for Police coverage starting February 5, 2020. The coverage hours for Montgomery Borough will be reduced. The budget can be reopened in January to address these issues.
