# Montgomery Borough Council August 10, 2021

\*\*Meeting was conducted by Zoom and publicly at Borough Hall.

Vice President Sanguedolce called the meeting to order at 6:30pm.

- I. All recited the Pledge of Allegiance.
- II. Roll call was taken: Jeff Frey Jr.-A; Joshua Geiger-P, Laurel Green-P, C. Roger McRae-P, Rocky Sanguedolce-P and Clayton Steward-A. Also present were Borough Coordinator Donna Miller, Mayor Edward Alexander and Solicitor Jonathan Dewald.
  - \*Vice President Sanguedolce stated no Executive session(s) have been held prior to this meeting.
- III. Fire Department Report. A written report was handed in, but no one was in attendance.
- IV. EMA Report. Greg Gruver had nothing more to report other than the written report.
- V. Public Concerns. Resident Margaret Mathis stated about the ongoing problems with area children. "What can be done?". Councilwoman Green stated about talking to the children, Mayor Alexander stated the children must be charged first and then the judge would order community service. Resident Ruth Little asked the solicitor is anything could be changed to help with this, he responded as the children must be charged first. Angie Adams asked what does the Police do with children that are out after the curfew hours, do they take them home??? Vice President Sanguedolce stated something will be figured out.
- VI. Approve July 13, 2021 Meeting Minutes. A motion was made by Laurel Green to approve; second by C. Roger McRae. Motion carried.
- VII. Approve July 2021 Treasurer's Report. This was tabled until next months' meeting.

- 5.The W. Houston Ave water replacement project was started, the delay was due to material; the water leak on Montgomery Street and 2<sup>nd</sup> Street was repaired, a BIG thank you to the Borough crew for their long day; the Timber Run project is progressing.

A roll call vote was taken, Jeff Frey-absent; Josh Geiger-yes; Laurel Green-yes; C. Roger McRae-yes; Rocky Sanguedolce-yes; and Clayton Steward-absent. Vote was 4 yes and 2 absent. Motion carried.

Resolution 2021-8-10; a Resolution to fill Council Vacancy. A motion was made by Josh Geiger to adopt Resolution 2021-8-10; second by Rocky Sanguedolce. Motion carried. Councilman McRae will swear Margaret Mathis into office after the meeting tonight.

### XVI. Public Comments.

Mayor Alexander stated the Firemen are having fireworks the final night of the carnival; Saturday, August 28<sup>th</sup>; donations will be accepted.

Councilman McRae asked if anyone remembered parking on W. Houston Ave. and why it was terminated. He also asked Attorney Dewald about the maintaining of right-of-way's, Attorney Dewald stated it would be reflected in the agreement on file, but if no agreement the property owners would have equal maintenance.

XVII. Adjournment. Motion was made by Laurel Green to adjourn the meeting at 7:10 pm; second by Josh Geiger. Motion carried.
