**Meeting was conducted by zoom and publicly at Borough Hall.

- 8. 2023 Montgomery Borough Budget-1st reading. This would be a no tax increase budget of \$540,342.00. A motion was made by Roger McRae to accept this; second by Margaret Mathis. A roll call vote was taken as follows: Josh Geiger-yes; Laurel Green-no; Ruth Little-yes; Margaret Mathis-yes; Roger McRae-yes; Rocky Sanguedolce-yes; Gary Yocum Jr.-yes. Six yes votes; One no vote. Motion carried.
- 9. Tax Levy Ordinance 2022-4. This is an Ordinance stating the Montgomery Borough tax rate for 2023. A motion was made by Josh Geiger to accept; second by Ruth Little. Motion carried.

XVI. Public Comments. Brad Feaster asked if any more discussions were held about the merging of the Police Department. President Sanguedolce stated no one was interested, but he can reach out to the Townships. A question was asked to the Fire Department about the Class 3A vests; Steve Cook stated these vests would be wore for numerous incidents. Councilman Yocum asked about organizing a meeting with the Townships to discuss Police coverage.
